

MEMBERSHIP APPLICATION Terms & Conditions

I. DEFINITIONS

The following definitions apply throughout these Terms and Conditions:

- “Applicant” means an individual or entity seeking admission to become a Member of Saudi French Business Council (CAFS).
- “Saudi French Business Council (CAFS)” means the Conseil d’Affaires Franco-Saoudien/Saudi French Business Council (CAFS) registered in the Kingdom of Saudi Arabia.
- “Member” means an individual or entity having successfully registered as a Member of Saudi French Business Council (CAFS).

II. HOW TO APPLY FOR MEMBERSHIP?

When applying for membership, the Applicant shall send the following documents:

- The online Membership Application Form dully completed with all required information.
- Logo of the Applicant’s entity.
- Picture of the Applicant’s main contact person(s) (General Management, Representatives, Country Manager...).

III. PAYMENT

Payment of membership fees is due upon reception of the invoice sent by the CAFS after reception of the Membership Application Form.

The Applicant shall check the below conditions regarding deadlines for payment of membership fees, refund, and termination of membership.

Payment can be either made by bank transfer or online by card on the CAFS’ website.

V. CONDITIONS

Payment of full membership fees by the Applicant gives rights to a whole year of membership, starting from the date of payment at any time during the year.

5.1 – Membership renewal

Renewal membership fees have to be paid in full one month before the end of the Membership. In case of non-payment of membership fees at the end of one-year term of the Membership, all membership rights and benefits will be forfeited and lost by the Applicant. In that case, the Applicant will not be considered to be a Member of Saudi French Business Council (CAFS) anymore until payment is received.

5.2 – New membership

Any new applicant must pay the full Membership fees for one year to become a member of Saudi French Business Council (CAFS). The Membership term is one full year starting on the date of payment of the Membership fees.

Applicants have to meet the conditions of the type of membership for which they apply. Saudi French Business Council (CAFS) reserves the right to terminate a membership, including without limitation, if the Member has provided false information, does not meet the conditions attached to its selected type of membership, or does not abide by the provisions of Saudi French Business Council (CAFS)'s Memorandum and Articles of Association.

In case of termination of the membership by Saudi French Business Council (CAFS), the terminated Member will only be entitled to the refund of its membership fees on a pro-rata basis calculated according to the remaining number of days until the end of the concerned one-year term of Membership.

5.3 - Refund of membership fees

Members of the Saudi French Business Council (CAFS) can request a refund of their membership fees for any reason, within the first nine (9) months following the payment of the membership fees. The request has to be done by official email sent to the CAFS.



In case a Member requests a refund of their membership fees, they will only be entitled to the refund of its membership fees on a pro-rata basis calculated according to the remaining number of days until the end of the concerned one-year term of Membership.

No refund will be granted in case the request come after nine (9) months following the date of payment of the Membership fees.

Once a Member has requested a refund, all membership rights and benefits will be forfeited and lost by the Member. In that case, the Member will not be considered to be a Member of Saudi French Business Council (CAFS) anymore, unless the company goes through the formal and official membership application process again.

I. COMMUNICATION

The use of “Member of Saudi French Business Council (CAFS)” logo is free of charge for Members under the following conditions: it should not be used to harm the image of Saudi French Business Council (CAFS) or the one of services offered by Saudi French Business Council (CAFS), it should not mislead any third party into believing that Saudi French Business Council (CAFS) in any way guarantees the quality of the products/services or the reputation of the Member making use of the “Member of Saudi French Business Council (CAFS)” logo.

The use of the “Member of Saudi French Business Council (CAFS)” logo cannot engage the responsibility of Saudi French Business Council (CAFS) in any way.

The “Member of Saudi French Business Council (CAFS)” logo remains the property of Saudi French Business Council (CAFS). In case of failure by any Member to abide by the above conditions or, more generally, in case of any use contrary to Saudi French Business Council (CAFS) interests, Saudi French Business Council (CAFS) reserves the right to prohibit the use of the “Member of Saudi French Business Council (CAFS)” logo and to require its immediate withdrawal upon written notice.

By applying for Saudi French Business Council (CAFS) membership, the Applicant agrees that upon becoming a Member, the Member’s contact details, and logo can be published by Saudi French Business Council (CAFS) in its annual Members directory, and included in all its communication or on its website.
